
DEFAULT
FINAL ORDER ON CHILD CUSTODY AND SUPPORT

THIS MATTER having properly come before the Court on a duly noticed Final Hearing on May 31, 2011, the Petitioner being present with counsel, D. Zane Swank, and the Respondent not appearing or otherwise defending, the Court hereby FINDS, ORDERS and DECREES:


1. The Court hereby adopts as its Ruling all provisions submitted in Petitioner's Proposed Resolution of Issues with the changes set forth hereunder.
2. The Parties shall have joint legal custody with Petitioner having primary physical custody and Respondent having supervised visitation with the Minor Children at Time 4 Families every other Saturday at Respondent's sole expense upon advance written notice. Respondent shall make all arrangements for supervised visitation, shall be responsible for the entire cost therefor and provide timely written notice to Petitioner if Respondent intends to exercise it.
3. Respondent shall pay ongoing child support in the amount of \$549.01 directly to Petitioner commencing on June 1, 2011 each and every month until further Order of this Court. See Child Support Worksheet "A" (attached as Exhibit "A") (imputing minimum wage to Respondent and using Petitioner's actual income).
4. No wage withholding shall be ordered at this time.

5. Respondent shall pay to Petitioner reasonable attorney fees and costs in the amount of \$1,809.34 which were incurred in the prosecution of this matter.
6. Judgment is hereby entered against Respondent in favor of Petitioner in the amount of \$1,809.34 and such Judgment shall bear interest at the statutory rate.


